Art. 1

Sirmione Award for the Photography

The District of Sirmione promotes the Sirmione Award for the Photography, 14th Edition, dedicated to Sirmione and the Garda Lake and organizes the:

LAKE GARDA PHOTO CHALLENGE

Art. 2

Participation

The contest is open to everyone, except for the Administrators, the employees of the Municipality of Sirmione, the members of the jury and their relatives.

Art. 3

Modality of registration and execution

The registration and the participation at the Award can be only executed following the modalities on the websites visitsirmione.com and sirmionefotografia.it

Art. 4

Registration costs

The registration cost is € 10 independently of the number of photo that will be presented

Art. 5

Procedures

The Photo Challenge is a competition for digital photographs dedicated to Lake Garda.

For the two main themes, Sirmione and Lake Garda, participants, at the scheduled deadline, will be able to deliver a maximum of three photographs (regardless of the chosen theme) for which the date of the shot is not relevant.

A fourth photograph is allowed for the theme Arie del Garda.

Images taken with digital devices (reflex, compact cameras and mobile phones) are admitted to the Photo Challenge.

Art. 6

Themes

The themes of the competition are:

SIRMIONE

LAKE GARDA

ARIE DEL GARDA

Maria Callas with her voice discarded the canons of melodrama to become a timeless icon of art and style.

Sirmione, where Maria Callas spent some of the happiest moments of her life, celebrates the singer inserting among the themes of the Sirmione Award for Photography ARIE DEL GARDA: an invitation to photograph the beauty, elegance, class, the timeless charm and uniqueness of Lake Garda.

Art. 7

Technical features of the photos

Digital photos sent must be exclusively in JPEG format, with not excessive compression (from average to minimum) and 300 dpi resolution, in the size (number of pixels on both sides) not reduced or scaled compared to those of the camera used and complete with all the original EXIF data of the shot, under penalty of exclusion from the competition.

The images must not contain white borders, signatures or recognizable logos, name of the participant written in digital watermark, signature on the photo or any other univocal sign of identifications. In no case will be accepted images in which have been added or removed key elements of the composition or obtained from cuts consisting of larger frames, such as photocomposition, photomontages, double exposures or anyway elaborations heavily influential on the aspect and the content of the pictures. The clipping of the images, also known as "crop", is not allowed, but for the little necessary size in case of straightening of the horizon of the images, as above written. Specifically, are allowed:

- Conversion from colour to black-and-white;
- Regulation of the tones (high lights and shades, hardness and softness);
- Regulation of the clearness, brilliance, contrast and saturation;
- Regulation of the colour profile used;
- Straightening of the horizon;
- Filters, which are physically placed on the camera (polarizers, cross-screen, soft focus and similar);
- Digital filters included in the most common software of elaboration of the images which are available to the public to modify the chromatic tones of the images, to lend dominants of colour, effects of imitation of the chemical images or others
- Particular techniques, such as Tilt&Shift, Dragan effect, HDR, Focus Stacking etc.

Each participant must conserve the originals in Raw or JPG, of which the Jury can request the vision; failure to display the original will result in exclusion from the competition.

The Jury will have the right to reject any image that has been too much retouched at the expense of the integrity of the contents and meaning of the original image.

Art. 8

Photographies' delivery

The delivery of the photos, exclusively in digital format, must be executed within Tuesday 31st October 2023 at 11:59 p.m. with the modalities that will be communicated to all who are registered and published on the websites visitsirmione.com and sirmionefotografia.it

Art. 9

Copyright

For each work sent for the participation at the Award, the candidate must declare under his own responsibility:

- that he is the real author of the work and that he has all the rights relating to it.
- that the work doesn't betray any right of a third party and doesn't violate any current regulation.
- moreover, he declares and guarantees that he is the holder of each moral and patrimonial right relating to the work.
- in any case the author relieves the organization from all the responsibilities, costs or burden of any nature, that might be supported due to the content of the work.
- that he grants to the District of Sirmione a full-use license, not exclusive, irrevocable, permanent and totally free. In any case the name of the author will be specified.

Pursuant to current legislation on the subject, each participant has the full right of ownership and use of the images created during the competition.

The photographs, at the discretion of the Jury, may be exhibited in an exhibition and published on the institutional website of the Municipality of Sirmione and on the Facebook page of the Municipality of Sirmione.

Art. 10

Exclusions

Any omissions or inaccuracies in the data on the registration form, or in any other form of documentation required to complete the registration process, may lead to the cancellation of participation in the event.

The photographs in the competition must not be published online (on forums, personal websites or social networks) before the award ceremony. Any publication will result in the exclusion of the photo(s) from the competition.

Photographs that have already participated in previous editions of the Award cannot be submitted

Art. 11

Responsibilities

The author of the photographs is the only person responsible of the content of them.

Photos, which could damage the personal dignity or in any way the image and the name of the Organizer, of the sponsors, of the Public Administration and of any other subject (natural or legal person), are not allowed.

In case of sending images, which damage the law regulations, the third party's right or even only inopportune, the author of these images will totally relieve the organization and he will keep it unharmed from any claim, economic or not, of a third party.

The organization is not responsible of the behaviour and of the acts of the participants.

Participants must behave prudently and responsibly, in order to respect the social regulations and to avoid any damage for the practicability and the citizenry.

Art. 12

Jury

The Award's Panel is presided by the Mayor of Sirmione and is thus composed:

Art. 13

Judgement of the images

The Jury's evaluation will take into account the consistency of the photographs with the assigned themes by evaluating the relationship with the places of Lake Garda and Sirmione.

Theme "Sirmione"

First prize - € 1.500,00

Second prize - € 500,00

Third prize - a long stay in Sirmione for two people (2 nights and breakfast)

Theme "Lake Garda"

First prize - € 1.500,00

Second prize - € 500,00

Third prize - a long stay in Sirmione for two people (2 nights and breakfast)

Theme "Arie del Garda"

First prize - a long stay in Sirmione for two people (2 nights and breakfast)

Second prize - a stay in Sirmione for two people (1 night and breakfast)

Third prize - a dinner for two at a restaurant in Sirmione

Special prize "Historical and archaeological heritage" - a long stay in Sirmione for two people (2 nights and breakfast)

Special prize "Cantine del Lugana di Sirmione"

First prize – a visit to a winery with guided wine tasting for two people and 6 bottles of Lugana wine

Second prize – a visit to a winery with guided wine tasting for two people and 4 bottles of Lugana wine

Third prize – a visit to a winery with guided wine tasting for two people and 2 bottles of Lugana wine

The Jury reserves the right to assign further prizes or, if it deems it appropriate, not to award all the prizes provided.

Additional prizes will be announced on the websites visitsirmione.com and sirmionefotografia.it.

All prizes are personal and non-transferable and, where applicable, must be collected personally by the winners during the award ceremony.

The prizes are not cumulative.
